### Symposium success

Close to 200 activists, policy-makers, researchers and lawyers came together again this year for the Legal Network's second Symposium on HIV, Law and Human Rights. Among many highlights, attendees heard a stirring keynote address by **Dr. Michel Kazatchkine, Executive Director of the Global Fund to Fight AIDS, Tuberculosis and Malaria**, who outlined the case for Canada and other G8 countries to increase their pledges to the Global Fund. Dr. Kazatchkine also gave numerous examples of how the struggle against AIDS must include advocacy for human rights, such as insisting on access to antiretrovirals for people in the developing world and health services such as supervised injection sites for people who use drugs, abolishing laws criminalizing gay men, and closing compulsory drug detention centres where people are abused in the name of addiction "treatment". The same evening, we also honoured lawyer **Ralf Jürgens** with the 2010 Canadian Award for Action on HIV/AIDS and Human Rights, presented jointly by the Legal Network and Human Rights Watch. Known by many in the community, Ralf has a long history of advocacy on AIDS and human rights in most regions of the world, including co-founding the Canadian HIV/AIDS Legal Network and serving as its Executive Director from 1998 to November 2004. Building on his numerous contributions to HIV/AIDS policy and human rights, Ralf continues his advocacy on a global stage, including on such issues as the human rights of people who use drugs and people in prison or other places of detention. ### "Now More Than Ever"

To date, over 700 HIV/AIDS organizations worldwide, including the Legal Network, have endorsed **Human Rights and HIV/AIDS: Now More Than Ever** in an attempt to place human rights at the centre of the global AIDS response. The joint declaration presents ten reasons why protecting human rights is essential to public health, particularly for a disease such as HIV that affects the most marginalized in society.

The *Now More Than Ever* campaign has grown since it was launched at the 2006 International AIDS Conference, and it will again figure prominently during the XVIII International AIDS Conference (AIDS 2010) in Vienna in July, when activists gather for an exciting program of activities in the **Human Rights Networking Zone** in the AIDS 2010 Global Village, co-hosted by the Legal Network and the Open Society Institute, with support from the Levi Strauss Foundation and the Open Society Initiative for Southern Africa. Human rights will also be highlighted prominently during the conference by an historic march, rally and concert for human rights on the evening of Tuesday, July 20. ### **Vienna Declaration**

The Vienna Declaration is a statement seeking to improve community health and safety by calling for the incorporation of scientific evidence into illicit drug policies. Scientists, health practitioners and the public are invited to endorse this document in order to bring these issues to the attention of governments and international agencies, and to illustrate that drug policy reform is a matter of urgent international significance. The declaration was drafted by a team of international experts and initiated by the International AIDS Society ([www.iasociety.org](http://www.iasociety.org)), the International Centre for Science in Drug Policy (ICSDP) ([www.icsdp.org](http://www.icsdp.org)), and the BC Centre for Excellence in HIV/AIDS ([www.cfenet.ubc.ca](http://www.cfenet.ubc.ca)). ### **CAMR campaign**

Although Parliament has risen for the summer, we still need you to help build support in Parliament to ensure passage of Bill C-393, a private member's bill which proposes to streamline Canada's Access to Medicines Regime (CAMR), created in 2004 to help export lower-cost, generic medicines to developing countries. The bill is slated for study by the House of Commons Standing Committee on Industry, Science and Technology when parliamentarians return to Ottawa this fall. In May, we reported that the Committee had received approximately 2,000 postcards, an unprecedented number. They have now received more than double the amount — some 5,500 postcards! During the summer, MPs are in their ridings and it's a perfect time to have a conversation with them. Tell them Bill C-393 would help ensure that lower-cost AIDS drugs reach people in developing countries who desperately need them. Our campaign needs your involvement to ensure a stronger base of support for the proposed reforms, in the face of powerful opposition from the brand-name pharmaceutical lobby and some MPs.
